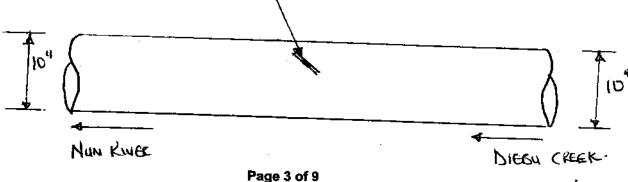
# SHOWING SECTIONAL VIEW OF 10" DIEBU-CREEK - NUNRWER PIRELINE AT EKOWE SHE.

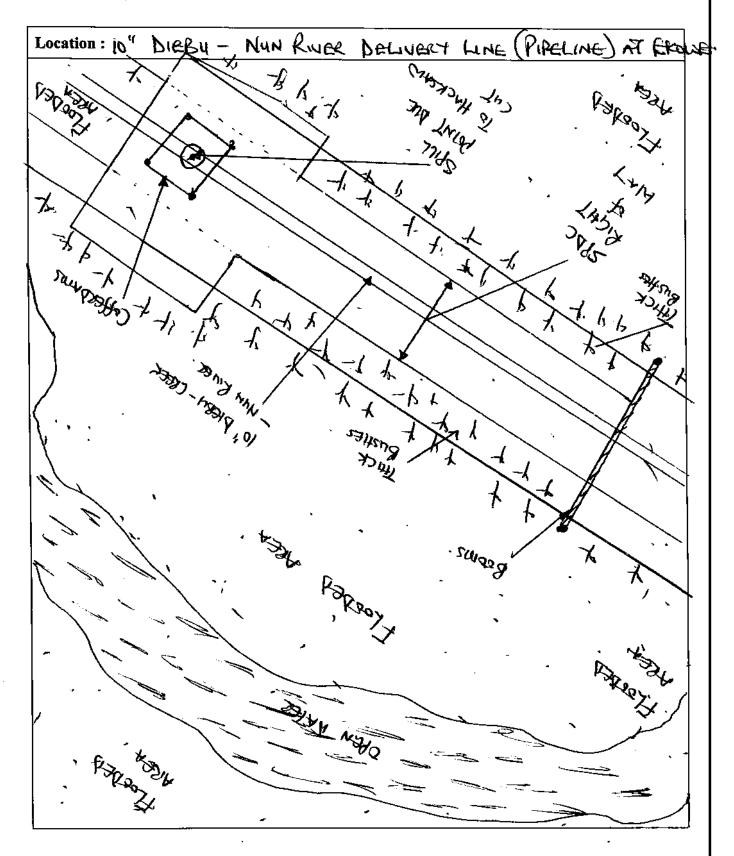
