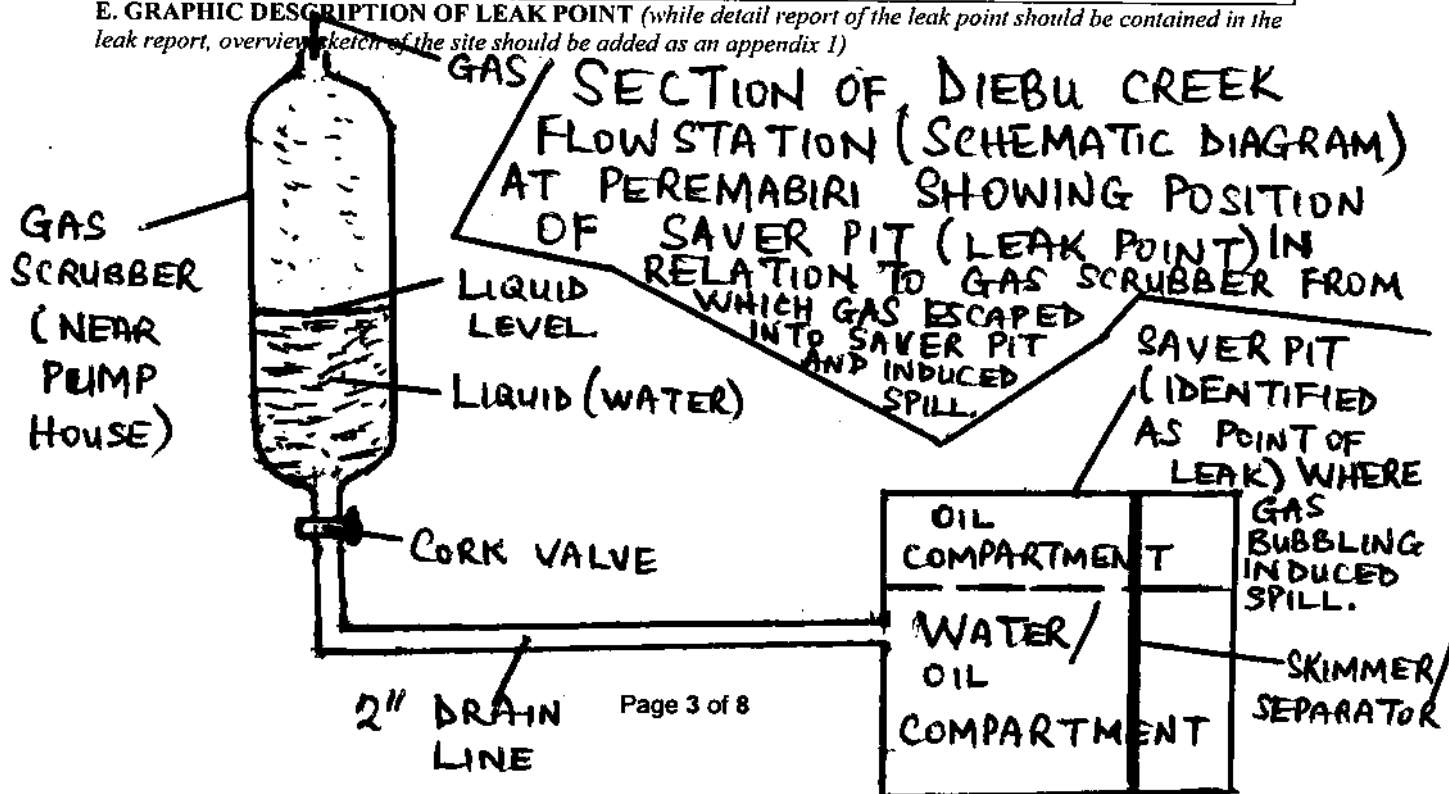

BASED ON THE OBSERVATION ON SITE THAT THE EXTENT OF IMPACTED AREA WAS WITHIN THE DEPLOYED BOOM, ESTIMATION OF SPILL WAS TREATED AS WITHIN A CONFINED WATER BODY.
