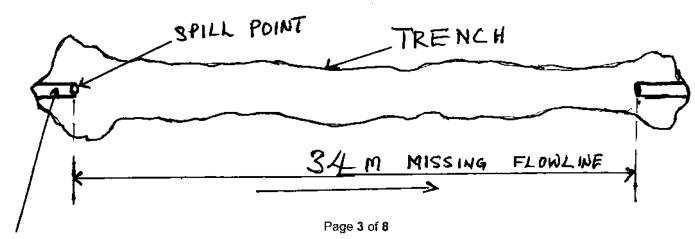

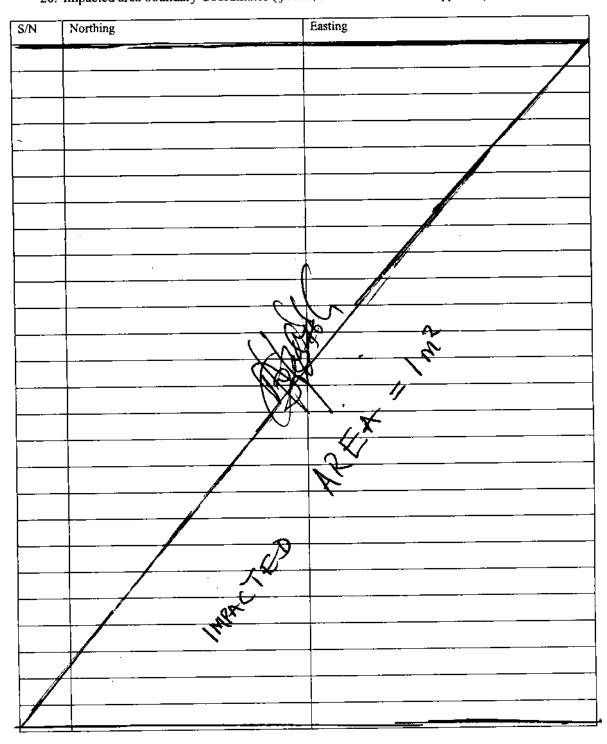
4" AHA WELL 3S FLOWLINE SHOWING 34 METERS
